# **ACE OF SPADZ**

## Conditions of breeding

- 1. A booking fee of \$750 (non-refundable) is payable at the time of booking the mare to stud and returning this contract. The non refundable booking fee is deductible from the breeding fee and is valid as a credit for one breeding season only. One form per mare required, please attached a copy of mare's REGISTRATION PAPERS.
- **2.** The mare to be bred must be healthy, in sound breeding condition, halter broken, unshod and well mannered.
- 3. In an emergency, Any staff or owners of Beljay Performance Horses has permission to call a vet if attention is required for the said mare. All veterinary costs are to be paid by mare owner under all circumstances.
- 4. The balance of breeding fee of \$2,550 is to be paid in full prior to any semen being released. Mares will not be released until such time that all veterinary expenses, agistment, handing fee/s or any other charges incurred on behalf of the mare owner have been paid to all relevant parties in full.
- 5. The Mare owner is to inform the stallion owner of the result of a 14 and 42 day pregnancy scan. A breeding certificate will be lodged to the relevant breed societies then sent to the mare owner at the end of the breeding season.
- **6.** The mare owner understands that any member or staff of Beljay Performance Horses is not responsible for accidents, sickness, death, injury or disease to the mare or foal; however it will take all reasonable precautions in its care and supervision. The owner understands and acknowledges that entering the said property entails safety risks and we will not be responsible for any accidents or injury to the mare, any foal, or the owner.
- 7. Breeding Certificates will not be issued unless the mare is registered with those Associations. Only owners whose accounts are paid in full including veterinary and agistment costs will be issued with breeding certificates.
- 8. The owner of the mare will be allowed two attempts using FROZEN semen to receive a positive result at the breeding price, any attempts beyond will be required to pay \$550 for a third attempt.
- 9. All Frozen semen remains the property of Robert and Kellie Parish collected, stored, distributed or sold by any other party without prior approval All excess un used semen is to be returned to Gene movers at the mare owners expense, including any handle fees that may occur.
- 10. The mare owner is responsible for the costs of shipment of frozen semen or chilled semen if applicable. Beljay Performance Horses or the stallion owner is not responsible for lost, damaged or delayed shipments.
- 11. As much notice is required for shipping chilled semen, a minimum of 48 hours. A semen request form must be completed and returned to Beljay Performance Horses prior to shipping. All breeding, shipping and collection fees must be paid in full prior to shipping. A minimum of 2 weeks notice is required for the shipping of frozen semen.
- 12. Semen must be used to breed 1 foal to the mare and not to breed another mare or breed more than 1 foal. Breeding by embryo transfer using the semen which results in more than 1 foal will incur a breeding fee for each additional foal.
- 13. A free return (Live Foal Guarantee) is given with return privilege the following season. It is understood that if the foal does not stand up and nurse for 48 hours, the mare owner will be entitled to a return privilege subject to conditions. The stallion owner must be informed within 1 week from death of foal and given a statement from a licensed Veterinarian of the death and that the mare is suitable for re-breeding. If the mare is to be returned and her owner fails to deliver her for re-breeding the following season, all fees will be forfeited and the guarantee lapses. No guarantee on the return privilege service unless there is prior approval with the stallion owner. The mare owner must pay all costs aside from the Breeding Fee.
